Official Event Rules

1. Teams consist of up to 12 unisex members, without substitutions if multiple heats/rounds occur.
2. Teams will pull a fully-loaded fire engine a designated distance for a recorded time, said time determining advancement/placement.
3. Participants must wear uncleated standard closed-toe tennis/running shoes. Gloves of any style are permitted.
4. Team Captains must check in between 11 and Noon and pick up shirts, and also participate in mandatory Captain's meeting at Noon.
5. The event will proceed rain or shine. Late or no-show teams forfeit their participation fees.
6. Ongoing and late-breaking communication will be made with each Team Captain using email.
7. Registration forms and payment **must** be received before Noon, August 28, 2017, in order to participate on September 2.
8. All participants must deliver a signed *Release, Waiver of Liability, and Assumption of Risk Agreement* prior to participating.
9. T-shirts for each registered team member are included (PLEASE be sure to supply sizes).
10. Trophies will be awarded for top places as well as *Best Costumes* and *Best Team Spirit*.

RELEASE, WAIVER OF LIABILITY, AND ASSUMPTION OF RISK AGREEMENT

In consideration for being granted permission to participate in the KCCFP Pumper Pull 2017 benefitting the Kendall County Community Food Pantry, on September 2, 2017 (“the 2017 Pull”) the undersigned, on behalf of the undersigned and all heirs, successors, executors, administrators and assigns, hereby fully releases, discharges and holds harmless each and all agencies, corporations, and sponsors involved in any way in the aforesaid 2017 Pull, including their members, sponsors, associates, and staff from any and all claims, actions, and liabilities which said undersigned and/or any successors may now have or which may accrue to any of the aforementioned by reason of the undersigned's voluntary participation in any of the activities and events relating to the 2017 Pull.

The undersigned agrees that prior to participating, he/she will inspect the facilities and equipment to be used and acknowledges hereby that he/she understands that each participant will be engaging in activities involving risk or serious injury, including permanent disability and death, and severe social and economic losses, which might result not only from the actions or inaction of the participant, but also from the intentional or negligent acts of others, from the rules of fair play and their application, from the condition of the premises and/or equipment, and from other causes now unknown or not now reasonably foreseeable. The undersigned acknowledges that he/she executes this *Release, Waiver of Liability, and Assumption of Risk Agreement* freely and voluntarily and does not rely on any inducements, promises or representatives made by the aforementioned organizations or individuals involved with the 2017 Pull, or of any person associated in any way therewith.

The undersigned agrees to abide by all the rules and regulations of the 2017 Pull and agrees to refrain from unsportsmanlike conduct or any conduct bringing discredit upon any participant, sponsor, or spectator. The undersigned agrees any physical or verbal assaults on officials, competitors, spectators, coordinators, volunteers or ex-officio will meet with expulsion from the 2017 Pull and any criminal or civil action against the undersigned, which is appropriate.
